

## **TERMS OF USE**

In these Terms of Use, "Website" means <https://www.fourwayscrossing.co.za/>; "you" means the person who makes use of the Website; and "Personal Information" means any personal details which you provide in any way through the use of the Website, in any form whatsoever, which includes but is not limited to your first and last names, telephone number, email address, and any other type of personal information as defined in section 1 of the Protection of Personal Information Act No. 4 of 2013 (hereinafter referred to as "POPI").
